

Great book. I get case files for rotations, with the intent of doing 2-3 cases/day, and always end up doing about 20 cases by the end of the rotation lol. I did have it on me throughout the rotation, and found the pharma tables very useful, especially because we learn the trade names for USMLE and then you'll mostly hear the generic names during rotations, which is included on the tables. Finally, I don't plan on becoming a psychiatrist, but I will keep this book in my library anytime I need to reference, in case I have friends or family that ask for advice from me in the future.

I teach a required course in diagnostics for graduate psychology students preparing for licensure. I find using clinical vignettes the best way to approach what will be done in actual practice. Case Files 5th ed. provides an excellent introduction to the process, includes definitions of the disorders, clinical considerations, differential diagnosis, treatment recommendations, and comprehension questions as well as the vignettes themselves. A well organized, and effective teaching tool that I enjoy using, and that students find helpful in managing a great deal of required information. Highly recommend but don't expect a discussion of the controversies over the DSM and the issues around psychodiagnostics.
