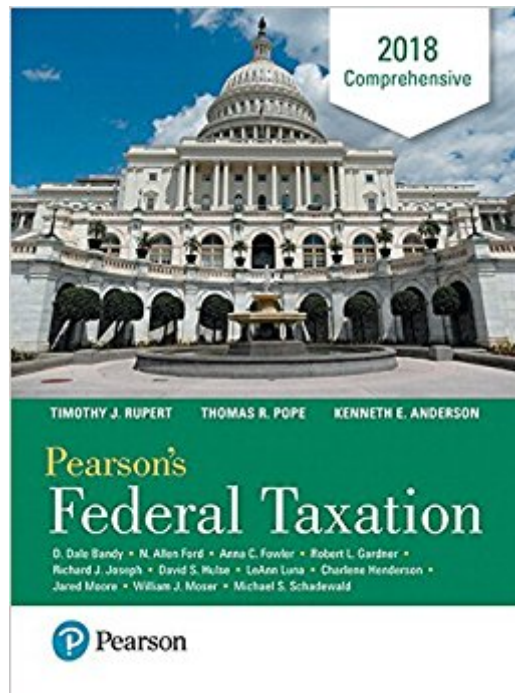

He has published articles in The Accounting Review, the Tax Adviser, Taxes, Tax Notes, and a number of other journals. Professor Popeâ™s extensive professional experience includes eight years with Big Four accounting firms.
