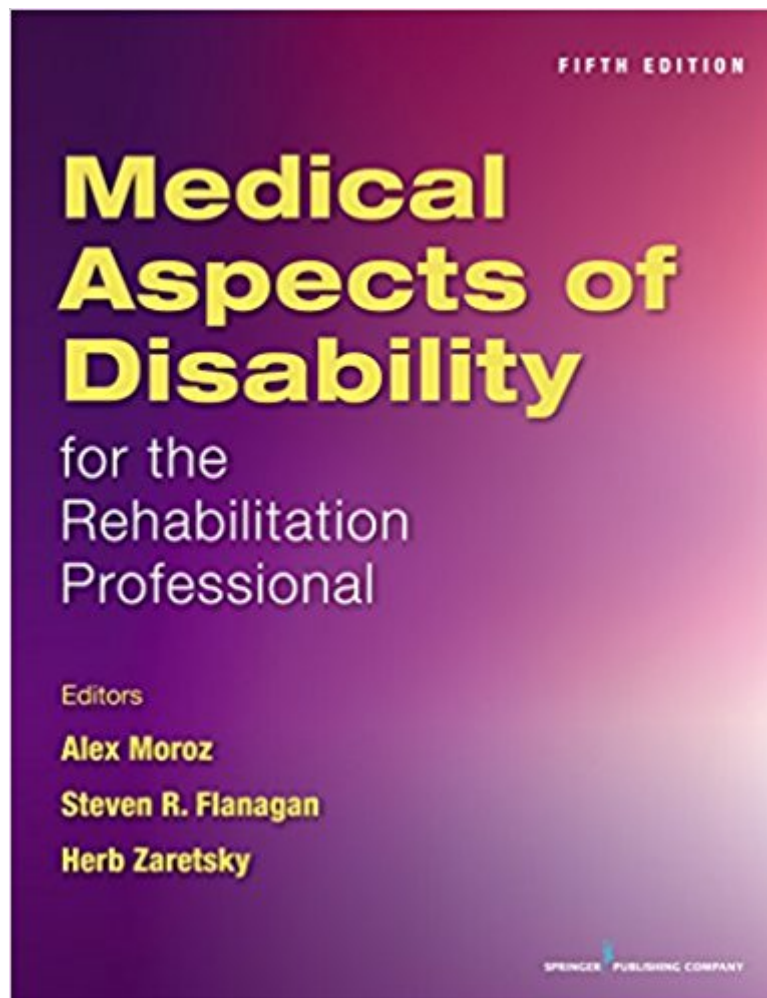

Division of Rehabilitation Psychology, and recipient of APA's Distinguished Contributions to Rehabilitation Psychology Award. He is a long-serving member of the board of directors of the national and international Commission on Accreditation of Rehabilitation Facilities (CARF) and currently is chair of the CARF board. Dr. Zaretsky was also formerly president of the board of directors of the American Cancer Society's (ACS) Eastern Division (New York and New Jersey) and the recipient of the St. George Medal, a national award from ACS in recognition of outstanding contributions to the control of cancer.
