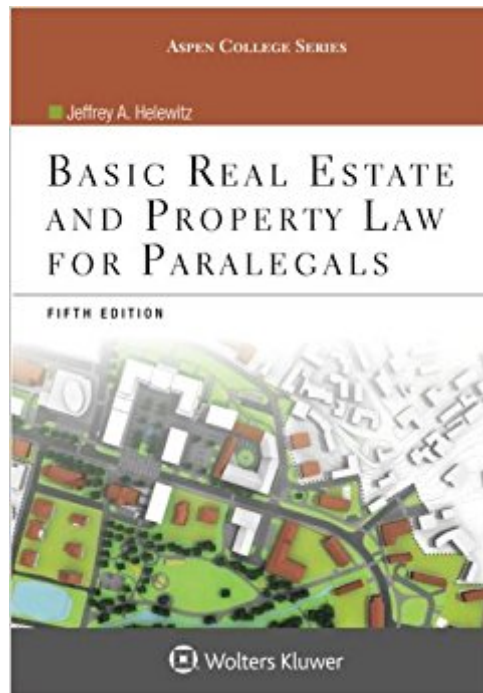

This book is very basic and even the instructor said it was not enough for the course at our University. It does give some good explanations of various real estate transactions but glosses over the details needed to examine these real estate transactions for chain of title or fraud. Since the book was written to be used nationally and all states govern real estate transactions differently, it is a pretty good starting point for this topic. Honestly, the only reason I bought it was because it was required for the course.

Excellent book for someone looking to understand Real Estate Law. It is written for the layman and is clear and concise. Some of the definitions in the book are different from the ones in the glossary. Makes study for test harder than it needs to be. Also at this price I would like to see some online study aids (which there were none). Otherwise the book is a keeper.
